

Financial Sanctions Notice

15.04.2014

Ukraine (Misappropriation and Human Rights)

Introduction

- 1. Council Regulation (EU) 208/2014, the Regulation imposing financial sanctions in relation to Ukraine (Misappropriation and Human Rights) has been amended so that an asset freeze now applies to the persons listed under the heading 'additions' in the annex to this Notice.
- 2. Identifying information for two individuals listed under the heading 'amendments' in the annex to this Notice has been amended.

Notice summary (Full details are provided in the annex to this Notice).

- 3. The following entries have been <u>added</u> to the consolidated list and are now subject to an asset freeze:
 - ARBUZOV, Serhiy (Group ID: 12946).
 - IVANYUSHCHENKO, Yuriy (Group ID: 12947).
 - KLYMENKO, Oleksandr (Group ID: 12948).
 - STAVYTSKYI, Edward (Group ID: 12949).
- 4. The dates of birth of the following entries have been amended:

What you must do

5. You must:

- i. check whether you hold any accounts, funds or economic resources for the persons set out in the Annex to this notice;
- ii. freeze such accounts, funds or economic resources;
- iii. refrain from dealing with such accounts, funds or economic resources, or making them available to such persons unless licensed by the Treasury;
- iv. report any findings to the Treasury, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of such persons that the Treasury may request. Information reported to the Treasury may be passed on, for example to other regulatory authorities or law enforcement agencies;
- vi. where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report these details again</u>.
- 6. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- 7. On 15 April 2014 Council Implementing Regulation (EU) No 381/2014 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 111, 15.4.2014, p.33) by the Council of the European Union.
- 8. The Amending Regulation amended Annex I to Council Regulation 208/2014, with effect from 15 April 2014.
