**SUBJECT : RESTRICTED ANCHORING ADJACENT TO
 FUJAIRAH TERRITORIAL WATERS
 BETWEEN LONGITUDES 056⁰ 35' E & 056⁰ 47' E**

Please be advised that considering the Safety, Security and environmental issues, vessels anchoring adjacent to Fujairah Territorial waters (between longitudes 056⁰ 35' E and 056⁰ 47' E) is strictly prohibited with immediate effect.

The coordinates of the areas are given below,

Area 1:

25⁰ 37.0' N & 056⁰ 35' E
 25⁰ 37.0' N & 056⁰ 47' E
 25⁰ 24.45' N & 056⁰ 35' E
 25⁰ 24.45' N & 056⁰ 47' E

Area 2 :

25⁰ 19.25' N & 056⁰ 35' E
 25⁰ 19.25' N & 056⁰ 47' E
 25⁰ 06.0' N & 056⁰ 35' E
 25⁰ 06.0' N & 056⁰ 47' E

Free passing of vessels through the aforementioned area (between longitudes 056⁰ 35' E and 056⁰ 47' E) is allowed as per International Maritime Law.

- i) Notice To Mariners No. 88 : Prohibited S.T.S Operations at Off Port Limit.
- ii) Notice to Mariners No. 153 : Restriction to serving vessels at Off Port Limit.
